

**MOUNT CALVARY CHRISTIAN SCHOOL  
STUDENT DRIVER FORM**

Driving to school is a privilege we afford our students. This privilege may be revoked at any time a student fails to meet Mount Calvary Christian School standards. PA Motor Vehicle Code Rules and Regulations will apply to all vehicles driven on school property. Violators will receive school consequences for violation of these guidelines as well as referral to the MCCS administration for possible prosecution under the provisions for the State Code. MCCS is not responsible for any vehicle damaged or stolen while on school property. Items kept in the vehicle are the responsibility of the driver. Doors should be locked at all times.

1. Must not display reckless or careless driving
2. Must park their automobile upon arrival and exit the vehicle immediately. Remember to lock your vehicle. Loitering in the parking lot before or after school is prohibited.
3. May not go to automobiles on the parking lot without permission from school authorities at any time during school hours.
4. May not transport any passengers in their vehicles during the school day without express permission from both parents (drivers and passengers) and the school. This does not include carpooling to and from school.
5. Must not be under any school disciplinary action.
6. The school administration may revoke, deny, or suspend student driving privileges if there is a suspension or expulsion from school and the reason for the suspension or expulsion is a violation of the drug and alcohol policy, tobacco policy, weapons policy or other infraction deemed appropriate by the school officials.

**SCHOOL'S RIGHT TO SEARCH**

Vehicles on school property are subject to searches. Search and seizure procedures may be assisted with the use of K-9 unit under the authority of the E-town Borough Police Department or Northwest Regional Police. Such procedures or items seized may be used as evidence against students in disciplinary, juvenile or criminal proceedings. Registration for a parking pass constitutes agreement for the vehicle to be searched and any items seized as deemed necessary should there be reasonable suspicion that drugs are in the car.
